Fishing, Hunting & Natural Resources Forum 2010 Legislative Bill Report # 4

Depending on your perspective the 2010 legislative session is either very productive or totally unproductive. The list of monitored legislation remains short with many of the bills listed in that section not receiving legislative action since the last report. Bills with activity are highlighted in blue. Those in the monitored section not receiving action are not highlighted but are retained in the list for reasons related to title content, potential budgetary implications and similar reasons. The budget continues to dominate virtually every discussion. SB 6813 (natural resource agency merger) is the hottest discussion topic among the hunting and fishing communities with universal strong to very strong opposition to the measure seen in all sectors of the regulated communities. The Senate budget released this morning (Tuesday) carries language implementing elements of the measure implying, even though the bill remains in committee, that the discussion regards the measure is far from over.
